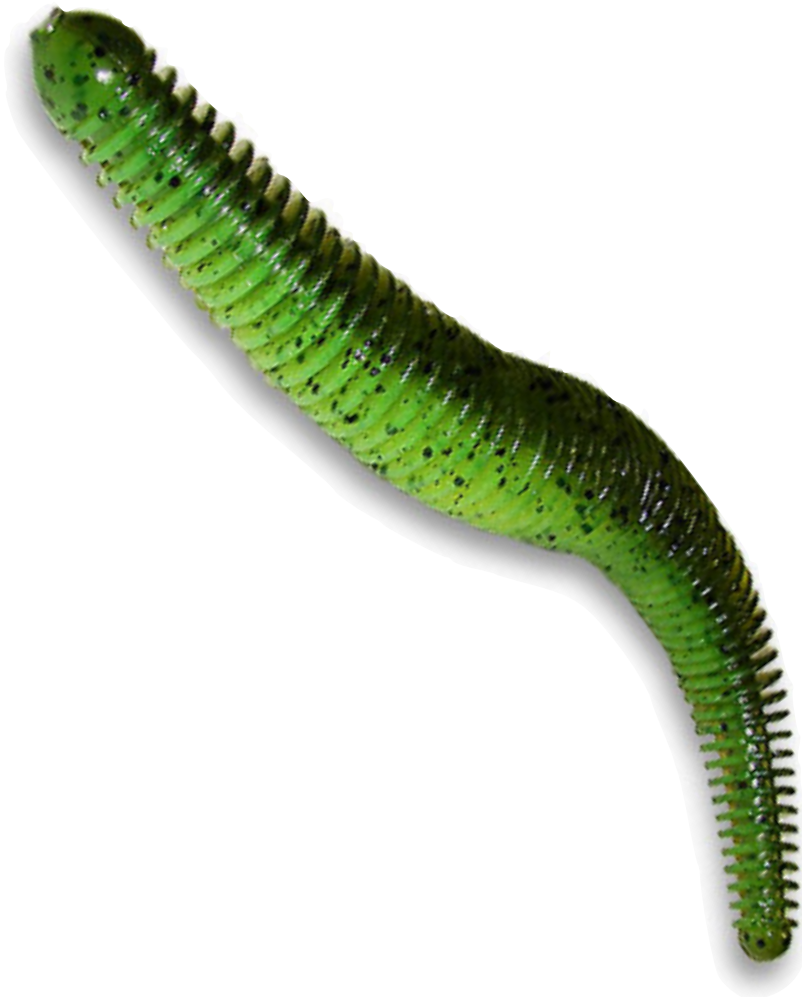
- 1. Jimmy and Richard: 8.81 lbs
