CLUB NEWS

Several important changes were made to the club rules at the last meeting.

- To be eligible for Top 8 a member must substantially participate in club's annual fund raising event. If necessary the club board will review member's participation level (Example: If a member sold only a single fund raiser raffle ticket - this could disqualify a member if extenuating circumstances do not exist.)
- Under no circumstances will a tournament be cancelled due to weather conditions. (All members fish at their own risk and should not fish in weather conditions they feel to be unsafe.)
- Boats not within 100 yards of the ramp at the end of the tournament will be disqualified.

Annual Awards to be presented next month... please come to receive and congratulate fellow members on their accomplishment! New club officers will be voted on at the August meeting, if you want to run for one of the positions or want to vote, please be sure and attend. It is important to remember that without meeting our club participation criteria you will not be allowed to fish the top 8. Several members who would be fishing this year were ineligible due to lack of participation.

Businessman Fishing tournament to benefit the Children's Advocacy Center is scheduled for September 12th, 7AM to 12PM at Lake Bastrop, North Shore .
